The primary objective of the proposed training programs is to ensure a comprehensive understanding of the solar PV Rooftop sector amongst stakeholders entering this sector. The five-days training programs are particularly focused on entrepreneurs who wish to start a Solar PV Rooftop business.

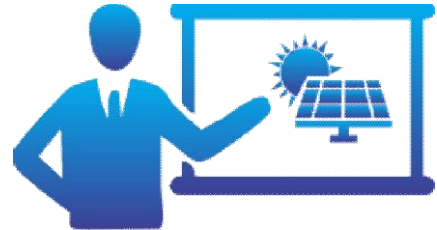
### Key Objectives of the Training Program

- Provide basic information on solar PV Rooftop and raise awareness amongst entrepreneurs on the following:
  - Concept, design and components with specific focus on technical architecture of solar PV rooftop system.
  - Policy and regulatory framework for Solar PV Rooftop at the national and state level.
  - Business models followed in the solar PV Rooftop market and role of respective stakeholders.
- Provide specific information to the entrepreneurs on the following :
  - Solar PV Rooftop project costing and financing.
  - Preparation of feasibility reports.
  - Tenders and techno-commercial reports.
  - Solar PV Rooftop project management.



### Training Fee and Lodging Expenses per Participant\*

- The training program is fully funded by The Program including lodging & boarding for the duration of training program.
- Participants will receive the Certificate from Skill Council for Green Jobs after successful completion of the course.
- Lunch and tea will be provided during the duration of the training program.
- A maximum of 40 seats are available under this training program for both local and outstation participants.



**Important Note: No Travel or Dearness Allowance will be provided to the participants for attending the training program.**

Participants will be provided certificates of participation upon successful completion of the training program as well as an Assessment will be carried out at the end of the program for Certification of Skill Council for Green Jobs

Interested candidates should fill up the enclosed Application Form and submit it LATEST by the **30<sup>th</sup> June 2019** to **the Director, Meghalaya New and Renewable Development Agency (MNREDA), Near BSF Camp, Mawpat, Shillong-793012** by email and Hardcopy should be submitted by **SPEED POST**, so that it reaches MNREDA office on or before **30<sup>th</sup> June 2019**.

List of Short Listed Candidates shall be uploaded on MNREDA website [www.mnreda.gov.in](http://www.mnreda.gov.in) before the commencement date and the candidates would be requested to confirm their participation by the stipulated date along with a draft of Rs. 5000 for General Categories and Rs. 2500 for ST/SC Categories of Meghalaya State as registration fee drawn in favor of **Director, MNREDA Payable at Shillong**. The draft will be kept by MNREDA during the course, and will be returned to the participant who complete the training program successfully. In case the candidate leaves the course in between, the draft shall not be refunded. The training course is completely free but this provision has been incorporated to ensure full participation in the course and making the program a success.

Since the training is being organized under the Entrepreneurship Development Program, the target participants include early-stage and medium-stage entrepreneurs who are interested in the process of launching Solar PV Rooftop business or established entrepreneurs diversifying their business to the Solar PV Rooftop space.



### Required Qualification of Participants

The Program is designed for entrepreneurs, startups and intrapreneur.

The following candidates are eligible to apply for the training program:

- Science Graduates
- Engineering Graduates (Mechanical, Industrial, Production, Electrical and Electronics)
- Management Graduates (Preference will be given to Science and Engineering Graduates)
- ***Non-Graduates with experience may also apply, they will consider for the training, if seats are available.***

During the selection process, criteria related to education qualification, focus sub-sector in the current business (solar and non-solar), age of venture into solar business and age of venture into non-solar business will be considered. Women are encouraged to apply for this training program. The decision taken by World Bank SUPRABHA TA Program will be final in the selection process.



**About the World Bank SUPRABHA TA Program:** Under the guidance of MNRE, the World Bank is supporting the Govt's program to generate electricity from the widespread installation of Grid-connected Solar Rooftop Photovoltaic (GRPV). In addition to lending, Ministry of New & Renewable Energy (MNRE) and the World Bank have launched a Technical Assistance (TA) program (SUPRABHA – Sustainable Partnership for Rooftop Solar Acceleration in Bharat) to address the barriers for accelerated GRPV installation.
