2. Instruction to Tenderer :-

- i) **Earnest Money Deposit** :- Earnest Money/cum Security Deposit at the rate of 1% of the quoted tender value for Scheduled Tribe and Scheduled Caste and 2% of the quoted tender value for General, in the form of BG/Call Deposit/FDR from any Scheduled or Nationalized Bank drawn in favour of Member Secretary-cum-Director, Meghalaya Non-Conventional and Rural Energy Development Agency, Shillong.
- ii) **VAT, Professional Tax Clearance Certificate** :- The Tenderers are required to submit VAT registration and VAT clearance certificate up to March, 2015 and also the Professional Tax Certificate from the concerned authority.
- iii) **Scheduled Tribe/Scheduled Caste** :- Scheduled Tribe/Scheduled Caste tenderers are to be submit the ST/SC certificate issued by the Deputy Commissioner of their respective District.
- iv) **Trading License** :- Non-Tribal tenderers are required to submit their Trading License issued from respective Autonomous District Council.
- v) **Labour License** :- Attested copy of up to date labour license should be submitted.
- vi) **CCM Training** :- Tenderers should possess CCM training certificate from MNREDA/Authorized Institution to be submitted along with experience certificate from any Competent recognized Institution.
- vii) **Attestation of supporting paper** :- All supporting papers are to be attested by a Gazetted Officer.
- viii) **Rate quoted** :- The rate quoted as per bidding schedule should be inclusive of taxes and duties and other incidental expenses.
- ix) **Name and address of the tenderer** :- Name and address of the tenderer should be indicated in a distinct manner.
- x) **Mason certificate** :- The tenderer should have at least 3(three) trained masons and Mason certificate should be submitted.
- xi) **Signing of tender paper** :- Tenders are required to sign and seal all pages of tender paper/document issued and it will be viewed as acceptance of the terms and conditions containing therein. Any unsigned tender papers will be automatically rejected.

- xii) **Payment Terms and Conditions :-**
- a) 70% will be paid on completion of work
 - b) 20% will be paid after successful commissioning of the plant.
 - c) 10% will be released after the guarantee period or on successful commission of the plant but on furnishing of BG/FDR of like amount valid for a period of 1(one) year.
- xiii) **Guarantee/Warrantee period :-** The Guarantee or Warrantee period of the plant is for 1(one) year from the date of commissioning of the plant.
- xiv) **Time of Completion :-** Work should be completed within 180 (one hundred eighty) days from the date of issue of work order.
- xv) **Submission of Bids :-** The tender is of two parts bid and should be submitted as below :-
- (a) General and Commercial Terms and Conditions as 1st bid in a separate sealed envelope which should consist of VAT Registration, VAT clearance certificate upto March,2015 Professional Tax clearance certificate, Scheduled Caste/Schedule Tribe certificate/trading license, CCM training certificate, Mason certificate, experience certificate or any other document.
 - (b) Price bid as 2nd bid in a separate sealed envelope which should contain EMD and price bid as per format in the tender document.
- xvi) **Target :-** The tenderers are required to indicate the target they are likely to complete within a specified date.
- xvii) **Preference :-** Preference of District is to be indicated and marked in section 4 of this document, without which the offer will be rejected.
in the 1st bid.
- xviii) **Distribution of plants/works :-** Distribution of work will depend upon contractor choice of District and as per target indicated in bidding scheduled.

- xix) **Undertaking :-** All successful bidders on finalization of work will be called and an undertaking has to be signed with the office with regards to target allotted as per their choice of preference.

3. CONSTRUCTION TECHNIQUES OF DEENBANDHU BIOGAS PLANTS SPECIFICATION.

To build a faultless Deenbandhu biogas plant it is essential that all the construction work is done in a systematic manner and by taking all the suggested precautions. The following is the sequence and details of the constructional methodology evolved for these plants.

The following points for selecting the site for installation a Deenbandhu Plant.

- i) The surface should be even
- ii) The site should be at a slightly higher elevation than the surroundings so that there are no chances of water logging in rainy seasons.
- iii) The site where the plant is to be installed should be as near to the point gas utilization as possible.
- iv) The site should be closed to the cattle shed to eliminate any difficulty during the collection of dung.
- v) Water availability near the plant is essential
- vi) The edge of the plant should be at least 2m (6 ft) away from the foundation of the house or any other buildings.
- vii) The avoid carrying of spent slurry to very long distances, the space for the compost P:1- should be available near the plant.
- viii) The location of plant should be at least 10-15 m (30-40 ft) away from any source of drinking water.
- ix) The bearing stress of the earth should not be very less to eliminate the possibility of sinking of the plant.
